

COOKIES POLICY

As the owner of 'Our Website' ASTILLEROS DE SANTANDER, S.A.U. informs you that we use data storage and data retrieval devices known as 'cookies' while users navigate Our Website.

What are cookies?

Cookies are small pieces of data sent from a website and stored on the user's computer by the user's web browser while the user is browsing. They store the user's IP address and other navigating data.

In general, cookies store and recover information on the user's browsing activity and collect and analyse information on users' preferences and browsing habits such as logging on sessions or any personalisation preferences of the user.

What kinds of cookies do we use and what for?

According to the Cookies Guide published by the Spanish Data Protection Agency, cookies are classified into three groups which are based on the entity that manages them, the amount of time that they remain active and their purpose.

Managing Entities

- *Same site cookies are those sent to the end user by the computer managed by the holder of the website being browsed and which provides services to the user.*
- *Third party cookies are those sent to the user's computer from a computer terminal not managed by the owner of the website, but by a third party.*

Length of Activation

- *Session cookies are those that collect and store information during the user's access to the website. These cookies disappear or are deleted once access has ended.*
- *Permanent cookies are those cookies that store collected data on a computer allowing this data to be accessed and processed for a period of time which is defined by the cookie manager.*

Purpose

- *Technical cookies are cookies that allow the user to navigate the website and enable access to different services and functions offered by the website.*

- *Analytic cookies are those that allow the tracking and analysis of the habits of users of websites for the development of user navigation profiles or the interpretation of website activity.*
- *Personalisation cookies are cookies that can be used to remember information about the user to show relevant content based on the user's preferences.*
- *Advertising cookies are those that permit the management of advertising preferences set by the website holder.*
- *Behavioral advertising cookies are those used by online advertisers to collect information about users' browsing behaviour to present targeted ads to consumers based on their preferences and on-line behaviour.*

ASTILLEROS DE SANTANDER, S.A.U. hereby notifies that we may use same site cookies as well as third-party cookies, some of which may not need specific previous consent by the user since they are not included among those requiring previous consent in LSSI act 22.2. We may also use cookies that do require previous consent by the user.
